Dear First Minister

RE: COVID19 measures placed against hospitality and tourism

We are writing to you on behalf of the hospitality and tourism sector in Gwynedd and North West Wales concerned about Welsh Government's ongoing policies placed against us. Gwynedd Tourism has grown to over 250 members in just 48 hours. We are deeply worried about the emergency lockdown we now all find ourselves- our remaining Christmas trade has now ended. It was not acceptable to give us just seven hours notice of these latest changes. Your comments saying "The economy will recover" were also concerning and felt out-of-touch from the reality we face on the ground. Many of our businesses hang by a thread. Your one size-fits-all, blanket approach in Wales is damaging our pubs, restaurants, cafes, bars, hotels, holiday lets and other businesses.

We recognise the challenges that exist in the management of COVID-19, especially where it is acutely felt in the south of Wales. We recognise how unbelievably difficult it is for you and leaders across the United Kingdom. We are not against COVID-19 measures either- our businesses have spent a lot of money ensuring we are compliant with the law and are contributing to the national effort to control the virus. But we want it to be noted that in Gwynedd and North West Wales, there has been low levels of virus transmission due to the hard work of local people. Anglesey has 40 cases per 100,000, Gwynedd 77 cases per 100k and Conwy 85. To have such extreme measures placed against the industry, an industry worth billions of pounds to the local economy, feels disproportionate to the threat posed to us.

Hospitality is the biggest private sector employer in the area and we help fund the public services we all rely on. We predominantly serve rural communities and therefore collectively help combat social problems too such as loneliness and isolation. And our businesses truly are at the heart of our local communities and we want that to continue. But your measures are doing irreversible damage to the sector.

Gwynedd, Anglesey and Conwy have a COVID-19 situation that is uner control. If we were to be using a tier system, we would likely be in Tier 1 or Tier 2. Under your latest tiering report, we would be Tier

2 which would allow businesses to sell alcohol with a substantial meal until 10pm. Whether Tier 1 or Tier 2, we could at least operate and begin the slow road back to recovery. We understand you seek to take a regional tiered approach as we come out of Tier 4 restrictions, but this needs immediate implementation.

This national lockdown for the whole of Wales affects North West Wales acutely for a problem that predominantly affects the South. This lockdown brings further anxiety and uncertainty to the hospitality and tourism sector, without an end in sight. It is a disproportionate course of action. Many businesses have not traded for many weeks as the ban of the sale of alcohol rendered them unviable. We do not know whether many businesses will emerge from this latest lockdown and should the alcohol ban remain in place till Spring, as the Western Mail reported, then that likelihood increases.

We write to you asking for the following to be implemented in Gwynedd and North West Wales:

- Ending the Wales-wide Tier 4 national lockdown restrictions in North West Wales, while the transmission of the virus remains stable and low.
- Moving to a regional tier approach immediately which recognises the prevalence of COVID-19 in each area with Gwynedd and North West Wales placed in a low tier.
- Publish the evidence behind hospitality causing the spike in infections.
- Ending the ban on the sale of alcohol for hospitality.
- Provide financial assistance for every week of lost trade.
- Consult with businesses and publish a Covid Hospitality Recovery Plan.

Many businesses have ceased trading for good and many jobs have been lost. There is an immediate need to take action and would welcome any efforts to engage with us to implement the aforementioned actions.

We look forward to hearing from you.
